Activities:

- On February 8, Wendy and I attended Maricopa's board meeting. Our charter renewal was unanimously approved by their board and is valid through July 2023.
- At the Maricopa Board Meeting, Scott Meier talked to Wendy and I about some different ways he wants to approach oversight next year which included breaking up the checklist over three visits. We all agreed this would be a less painful approach to getting through the checklist.
- On January 18, the P2P Science Fair and History Day was held at the clubhouse. A fabulous newspaper article about the event was printed in the paper.
- Ann Coyle, David Mack and I attended the CAASPP training in Bakersfield Feb 15-16. The teachers and I will be meeting to review what we learned in the training and to discuss interim testing for our school.
- \$300 so far has been donated to our after school program "Bear Academy" over and beyond the \$900 approved from SAC. The program is very popular with the students and is at full capacity. Over 1/3 of our students are in the program and we also have a waiting list. Yesterday, Mary Ann had Dionne work with each student on photography to submit for the photography contest.
- Two IEP meetings and several parent meetings were held this month.
- In particular, two family meetings were held with parents who were ready to unenroll their students over similar frustrations. Through careful negotiation and diplomatic efforts, these families with a total student count of 5 have agreed to wait to see if a student supports and teacher accommodations may work to improve their student's learning experience in the Blue Jay's classroom in particular.
- February Life Skills are "Resourcefulness and Initiative." I will be handing out awards next week.
- CAASPP Testing Window is set for 4/23-6/1/18. Still concerned about the internet. ☺
- Sign language is being taught by Shanene Laudenberg in the Quail classroom.
- Peer tutoring was set-up starting with one student and with the hope to extend it to more students.
- New play for end of the year program: Social Skills: How to Interact with Human Beings.
- Much time has been spent on staff support and classroom evaluations.
- Grace Phillips, our RSP teacher, will be going out on maternity leave sometime in the month of March. She is due March 10.
- The Barton Reading program was started this year and is expanding to include more RSP students with reading challenges. Grace is leading the program, but Shanene Laudenberg is also meeting with students to provide this training. One student who is also experiencing some reading challenges, but is not part of RSP yet, is also a part of the program.


Research:
