  9. Motion to approve Leave of Absence for Terry Page, a maximum of 12 workweeks, if needed, and no more than 12 weeks.

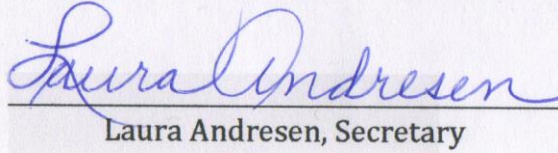
